### **Questions to Ask Hospital Personnel During Care Conference**

 Prior to administering the current protocol in place which is invasive mechanical ventilation, did you perform such and act pursuant to the Nuremberg Code and ORS 677.097 – Procedure to Obtain Informed Consent of Patient which states the following:

(1) In order to obtain the informed consent of a patient, a physician or physician assistant shall explain the following:

- a) In general terms the procedure or treatment to be undertaken;
- b) That there may be alternative procedures or methods of treatment, if any; and
- c) That there are risks, if any, to the procedure or treatment.

(2) After giving the explanation specified in subsection (1) of this section, the physician or physician assistant shall ask the patient if the patient wants a more detailed explanation. If the patient requests further explanation, the physician or physician assistant shall disclose in substantial detail the procedure, the viable alternatives and the material risks unless to do so would be materially detrimental to the patient. In determining that further explanation would be materially detrimental the physician or physician assistant shall give due consideration to the standards of practice of reasonable medical or podiatric practitioners in the same or a similar community under the same or similar circumstances. (d) The recognized serious possible risks, complications, and anticipated benefits involved in the treatment administered and in the recognized possible alternative forms of treatment, including nontreatment.

(4) If a recognized health care emergency exists and the patient is not legally competent to give an informed consent and/or a person legally authorized to consent on behalf of the patient is not readily available, his or her consent to required treatment will be implied.

- 2. Are you aware of the fact that Hydroxychloroquine and Ivermectin are approved antiviral treatments that are listed on the NIH's Table2e of Approved Anti-viral treatments and has shown very positive and successful results in treating pulmonary toxicity or what is referred to as COVID-19? (Present them the attached list)
- 3. Are you aware that a Highly Toxic Metal Poisoning Treatment Protocol can also treat and heal the symptoms of pulmonary toxicity? (Present them with the attached list)
- 4. If you refuse, for any reason, to comply with any terms and conditions of treatment set forth in the advance directive, would you be willing to turn the advocacy over to another physician or practitioner that will comply with the terms and conditions of treatment set forth in the advance directive?
- 5. Are you aware that if any rights of the patient are refused, dishonored or infringed upon, or the rights of kin or spouse, who possess advocacy rights, are refused, dishonored or infringed upon, which include, but are not limited to, a support person (family, kin, spouse) present at all times and no administration of treatment outside of what is prescribed on the advance directive, you could be criminally charged according to 18

U.S.C § 241 - Conspiracy against rights and/or 18 U.S.C § 242 - Deprivation of Rights under color of law?

#### 18 U.S. Code § 241. Conspiracy against rights

If two or more persons conspire to injure, oppress, threaten, or intimidate any person in any State, Territory, Commonwealth, Possession, or District in the free exercise or enjoyment of any right or privilege secured to him by the Constitution or laws of the United States, or because of his having so exercised the same; or

If two or more persons go in disguise on the highway, or on the premises of another, with intent to prevent or hinder his free exercise or enjoyment of any right or privilege so secured—

They shall be fined under this title or imprisoned not more than ten years, or both; and if death results from the acts committed in violation of this section or if such acts include kidnapping or an attempt to kidnap, aggravated sexual abuse or an attempt to commit aggravated sexual abuse, or an attempt to kill, they shall be fined under this title or imprisoned for any term of years or for life, or both, or may be sentenced to death.

#### **18 U.S. Code § 242.Deprivation of rights under color of law**

Whoever, under color of any law, statute, ordinance, regulation, or custom, willfully subjects any person in any State, Territory, Commonwealth, Possession, or District to the deprivation of any rights, privileges, or immunities secured or protected by the Constitution or laws of the United States, or to different punishments, pains, or penalties, on account of such person being an alien, or by reason of his color, or race, than are prescribed for the punishment of citizens, shall be fined under this title or imprisoned not more than one year, or both; and if bodily injury results from the acts committed in violation of this section or if such acts include the use, attempted use, or threatened use of

a dangerous weapon, explosives, or fire, shall be fined under this title or imprisoned not more than ten years, or both; and if death results from the acts committed in violation of this section or if such acts include kidnapping or an attempt to kidnap, aggravated sexual abuse, or an attempt to commit aggravated sexual abuse, or an attempt to kill, shall be fined under this title, or imprisoned for any term of years or for life, or both, or may be sentenced to death.
